

NCPGA ANNUAL MEETING Monday, December 4, 2017 North Ridge Country Club – Fair Oaks, Calif.

I. Welcome & Opening Remarks

- a) Interim Executive Director Nancy Maul reviewed the morning's agenda and thanked attendees and all those who have provided assistance to the Section Office in the absence of our late Executive Director & COO, Chris Thomas, PGA.
- b) IED Maul invited President Bill Troyanoski to the podium to officially call the meeting to order.
