

NCPGA SEMI-ANNUAL MEETING Sunday, June 26, 2022 The Row, Silver Legacy, Reno, Nev.

I. Welcome & Opening Remarks - Executive Director & COO Len Dumas, PGA

- a) Executive Director Dumas reviewed the evening's agenda and welcomed everyone to the meeting as a time to conduct business of the Association and to celebrate the new inductees to the Section's Hall of Fame.
